

GF LACROSSE LLC LIABILITY RELEASE, WAIVER AND INDEMNIFICATION

I, the undersigned, request voluntary participation in or attendance at the GF Lacrosse, LLC dba New York Riptide training academy camp and related activities on August 24-26, 2020 (all of which are referred to as the "Activity") operated by GF Lacrosse, LLC and its affiliates (herein collectively defined as "RIPTIDE"), for myself, and each person listed below (myself and each one a "Participant"). I have also completed the COVID-19 questionnaire as required by New York State.

ASSUMPTION OF RISKS: I consent to each Participant's participation in the Activity and acknowledge and understand that participation in the Activity may involve the risk of serious injury or death. I intend to and do assume all risks related to the Activity, including damages or losses which may result not only from Participant's own actions, inactions or negligence, but also from the actions, inactions or negligence of third parties or others, or from the condition of the facilities, equipment, or areas where the Activity is being conducted.

INDEMNIFICATION AND RELEASE: In consideration for participation in the Activity, each Participant, his or her parent or guardian (if applicable), and each Participant's heirs and assigns, intend to release, indemnify, save and hold harmless RIPTIDE, its members, managers, affiliates, officers, successors and assignees, employees, other Participants, insurers, licensees, sponsoring agencies, sponsors, advertisers, agents, event staff, volunteers, all sponsors, spectators and anyone connected with the Activity, including owners and lessors of the premises used to conduct the Activity. For avoidance of doubt, specific parties that I intend to release and indemnify include the following parties and their affiliates: GF Lacrosse LLC dba New York Riptide and GF Capital Sports Holdings, LLC (together with affiliates, "Released Parties"). I hereby release and indemnify the Released Parties from, and do discharge and waive, any and all actions, causes of actions, claims, demands, judgments, losses, damages, costs (including attorney's fees), or liabilities that I or Participant may incur or sustain and arising out of or in connection with participation in the Activity. I further covenant not to sue any of the Released Parties, now or in the future.

PUBLICITY RELEASE: I hereby irrevocably grant to RIPTIDE, its past and present affiliates, subsidiaries, parent entities, licensees, successors and assigns, the absolute, perpetual, and unrestricted right and permission to record, copy, reproduce, adapt, edit, summarize, copyright, photograph, film, license, vend, rent, distribute, televise, publish, exhibit, disseminate, perform and otherwise exploit in any and all markets and media Participant's participation in the Activity, other property, views, performance, efforts, trademark or trade name, biography, artistry, recorded image and voice. I grant my irrevocable permission to the organization to use my name and photographs, video tapes, recordings or any record of my participation in this event for any purpose. This grant of rights is made without limitation.

HEALTH CERTIFICATION: I certify that each Participant, including myself, is in good health and has no physical condition that would prevent participation in this Activity. I certify that I have adequate insurance to cover any injury or damage a Participant or I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage to the Participants or to myself. I consent to emergency medical treatment in the event such care is required. I am not

pregnant. I further certify that my ability to participate in the Activity is not impaired by the use of alcohol, marijuana, or any other controlled substance. I will not undertake the Activity while under the influence of alcohol or any drug.

ACKNOWLEDGMENT: I acknowledge, appreciate, and agree that I have read this form and understand that by signing this form, I am giving up substantial legal rights and remedies. I also acknowledge that I can comprehend English well enough to understand all advice, direction, and commands given by RIPTIDE staff members and volunteers.

I also agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue to be in full force and effect.

I warrant and represent that I am at least eighteen (18) years old and have been duly granted authority by each Participant listed below or by the parent or guardian of each minor person Participant listed to enter into this agreement on behalf of such Participant and such Participant's parents and guardians. I will provide written documentation of parental/guardian consent if I am not the parent/guardian of the Participant.
